

Collector class

Minnesota statute 168.10

Please note: Any vehicle registered in this class must be owned and operated solely as a collector's item and not for general transportation purposes. At the time of application, the owners must certify that they have one or more vehicles registered in their name with regular Minnesota license plates and the registration must be current. Vehicles registered in one of the collector classes have the option of displaying one or two license plates. All other vehicles must display plates on both front and back. Plates with asterisks (*) cannot be ordered online.
